### WAIVER AND RELEASE

In consideration of being allowed to participate in any way in the Tillman County Historical Society Crazy Day event and related activities, the undersigned acknowledges, appreciates, and agrees that:

- 1) The risk of injury from the activities in this program is potentially significant, and includes, but is not limited to, the risk for permanent injury, paralysis and even death; and,
- 2) I knowingly and freely assume all risks, both known and unknown, even if arising from the negligence of the Releasees or others, and assume full responsibility for my participation. I acknowledge that I am responsible for arranging my own liability insurance coverage for my own protection if I so choose; and,
- 3) I have read, understand and agree to comply with the rules of the event. I further understand and willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such attention to the attention of the nearest official immediately; and,
- 4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless, waive, discharge, and covenant not to sue the Tillman County Historical Society, its officers, officials, agents, volunteers, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("Releasees"), with respect to any and all injury, disability, death or loss or damage to person or property including theft, whether caused by negligence of the Releasees or otherwise in consequence of or in relation to my participation in the Crazy Day event.

I have read this Release of Liability and Assumption of Risk Agreement, fully understand its terms, and understand that I am giving up substantial rights by signing it, including but not limited to the right to sue, and I am signing it freely and voluntarily without any inducement and I further agree that no oral representatives, statements, and inducements apart from the foregoing written agreement have been made.
